Delays may occur if we cannot contact you and we will not be responsible for any costs arising due to such delays. Subject to your account's terms and conditions, withdrawals payable to you can be issued from your account by FASTER PAYMENTS, CHAPS and International SWIFT payment. We do not issue payments by cheque. The FASTER PAYMENTS method is only available for amounts of up to £100,000 remitted within the Sterling area (Isle of Man, United Kingdom, Channel Islands and Gibraltar). Payments of over £100,000 will need to be remitted by CHAPS (please see above) International payments may take several days to reach their destination due to delays resulting from differences in time zones and the number of correspondent banks involved in the payment.
